If your name is not printed on the TAMILNAD MERCANTILE BANK LIMITED cheque leaf, send us a scanned copy of the most recent month's TAMILNAD MERCANTILE BANK LIMITED bank account statement, to help@scripbox.com. You can send us a printed paper copy if you prefer.
- ☐ **E-mail us a clear picture of a signed bank mandate to help@scripbox.com** in order to automate your investments. This is also required for automated rebalancing of your investments. You can send us a printed paper copy if you prefer.
- ☐ To complete your paper-based Know Your Customer (KYC) process, **please post or courier these documents to our address below:**
 - ☐ **A signed paper KYC form** with a photo pasted and signed across
 - ☐ **A signed copy of your PAN card**
 - ☐ **A signed copy of your Driving License**
 - ☐ This is required, along with a **video selfie**, by law, for all first-time mutual fund investors

If you've requested for a printed KYC form and postage-paid return envelope, you will receive a courier from us in 3-4 working days.

This can be skipped if you've scheduled a door step verification (currently offered in select areas of Bangalore).

Once we get these, you can start investing after

- **1 working day:** for us to activate your Scripbox account. If your bank supports Net Banking for mutual funds (e.g. SBI, HDFC, ICICI, Axis), you can start investing immediately thereafter.
- **10-15 working days:** For monthly investments (SIPs), or for banks that don't support Net Banking, it takes your bank 10-15 working days to link your bank account to your Scripbox account, using the bank mandate signed by you. But you can go ahead and schedule your investments even while this is in progress.
