General Policies:

- Please treat this as a valid invoice for the purpose of service tax.

- PSF/UDF/ADF is collected on behalf of Airport Authority of India (AAI) / Airport Operator.
- Domestic Tax on passenger transport is collected @ 14.50% with an abatement of 60% (inclusive of education cess and secondary and higher education cess). On other services, service tax is collected @14.50% with an abatement of 60% (inclusive of Swacha Bharath Cess)

Cancels and Changes: Changes/cancellations are permitted up to Two (2) hours prior to scheduled departure with the payment of difference of fare if applicable and change/cancellation fee of INR 1500 per Passenger per Sector for all fare types .At any time after a Booking has been made, airpegasus may change our schedules and/or cancel, terminate, divert, postpone, reschedule or delay any flight where we reasonably consider this to be justified by circumstances beyond our control, or for reasons of safety, or for commercial reasons. Circumstances beyond Air Pegasus control can include, without limitation, weather, air traffic control, mechanical failures, and acts of terrorism. Acts of nature, force majeure, Strikes, riots, wars, hostilities, disturbances, governmental regulations, orders, demands or requirements, shortages of critical manpower, parts or materials, labor unrest etc.

If an Air Pegasus flight is cancelled, rescheduled or delayed for more than three hours (depending on the length of the journey), a Customer shall have right to choose a refund; or reschedule to future flights at no additional cost (subject to availability); subject to the requirements under the local laws of the country . We strongly recommend all customers to provide correct phone and email address, to enable us to update you about flight delays or cancellations in unforeseen cases. Customers who have not provided valid contact information at the time of booking may not be entitled for any compensation. Name changes are not permitted on your booking.

Checking timings: Passengers are advised to report for check-in at least 2 hours prior to departure. Check in counters will close 45 minutes prior to schedule/revised departure. Air Pegasus reserves the right to refuse acceptance of a passengers who do not adhere to check-in timings. The booking of such passengers would be considered as "NO SHOW" and the passenger shall be eligible for refund of Taxes and Govt/Airport fees only.

Boarding: The boarding gate will be closed 20 minutes prior to the departure. The passengers are required to be present at the boarding gate no later than the time specified by Air Pegasus when they check-in.

Baggage Policy: Free baggage allowance is 15kg per passenger, and 7kg of cabin baggage (only one piece, excluding ladies hand bags ,laptop - dimension measuring not more than 55 cm x 35 cm x 25 cm). Any excess baggage will be charged @ RS. 250/ Kg. For international connecting passengers the travel is within 24 hrs excess baggage will be discounted to Rs.150/Kg on production of international travel air ticket copy to check in staff. Infants are not eligible for Check in Baggage.

ADDITIONAL INFORMATION

Frisking of passengers by security personal is mandatory at all airports in India , passengers may kindly cooperate.

Air Pegasus reserves the right to vary, amend or alter these regulations at any time without notice. Air Pegasus Flight Schedules are subject to change and approval by authorities.
